

Open-ended Working Group taking forward multilateral nuclear disarmament negotiations

On Monday, 22 February 2016, the open-ended working (OEWG) taking group on forward multilateral disarmament negotiations, established by the Assembly General pursuant to resolution A/RES/70/33, commenced its substantive session in Conference Room XIX at the Palais des Nations, Geneva.

The mandate of the OEWG is to substantively address concrete effective legal measures, legal provisions and norms that will need to be concluded to attain and maintain a world without nuclear weapons (operative paragraph 2).

It is also mandated, in operative paragraph 3, to substantively address recommendations on other measures that could contribute to taking forward multilateral nuclear disarmament negotiations, including but not limited to:

- (*a*) transparency measures related to the risks associated with existing nuclear weapons;
- (b) measures to reduce and eliminate the risk of accidental, mistaken, unauthorized or intentional nuclear weapon detonations;
- (c) additional measures to increase awareness and understanding of the complexity of and interrelationship between the wide range of humanitarian consequences that would result from any nuclear detonation.

At its opening meeting, the OEWG elected acclamation by Ambassador Thongphaki Thani (Thailand) as Chairperson. The OEWG also heard a statement delivered former by Secretary-General, Mr. Kofi Annan.

accordance with In its indicative timetable for the first session (see below), the OEWG then commenced its first panel discussion, which addressed the substantive issues contained in operative paragraph 2. Its objective is to assess in depth relevant existing international legal measures. provisions and norms as well as to identify all elements in this regard that are necessary for multilateral progress towards a nuclear-weaponsfree world.

the exchange During of views on Monday and Tuesday, Panel I sparked a lively, interactive exchange and substantive of views among the participating representatives of States and civil society. The discussions addressed a variety of issues, including what would constitute "effective legal measures" and what many view as a "legal gap" in the international legal framework for nuclear disarmament. Various views were expressed on the feasibility of and possible options for legal instruments on nuclear disarmament. On Wednesday, 24 February, the OEWG will conclude its exchange of views on the items allocated to Panel I.

Commencing on Thursday, 25 February, Panel II will deal with the substantive issues contained in operative paragraph 3. Its objective is to address other measures that could contribute to taking forward multilateral nuclear disarmament negotiations, including the three subitems reflected in that paragraph.

At the end of the first session it is anticipated that the Chairperson will provide additional information on the forthcoming sessions of the open-ended working group, including the elaboration of recommendations to the General Assembly.

The first session will continue until 26 February. The second session is scheduled to take place from 2 to 13 May and the third session is scheduled to take place for a total of three days during the week of 22 August.
